Regarding Paul I had mentioned it before as although he is low life there is also a lot worse going on here. That's why I wondered what the connection was as I had assumed you might have met at some point. In the same way my first meeting of Paul resulted him finding it normal sticking his finger inside Vivian's vagina in front of a Nipa hut of people on a boat trip before having sex with her in the sea while kids were busy playing sand castles. That's when I met the "Real Paul" and from then decided not to associate with him. I haven't heard or seen Bob involved in any sexual activities but I have seen him use people to get what he wants in a business sense such as going to sporting events with expats to try and get a job out of some of the wealthier ones.

Why did I take him as a moderator? because to dismantle LinC you have to take anything that is a resource, you probably noticed Bob hasn't done much on LiC same as no talking on the Paul topic he's sitting on the fence to see what benefits himself. I don't trust Bob and never have done at the same time he can be replaced at anytime.

Norseman/Tim is pretty harmless and lives a fairly sheltered life, you have to wonder why Paul has a fairly extensive network system including load balancing for multiple internet connections at his place in Carcar though. Well Tim installed it and I can't understand why Paul would need all that equipment unless running something illegally from his accommodation. But I will need to meet Tim in person to find out exactly what he's installed to way up if its to do with Cybersex or something else. Also Tim isn't involved in the sex industry.

Markham moved down to CDO to get away from the sexpats of Cebu also not involved with the sex side of things. He also wouldn't invest in Pauls lending because of moral issues as well as couldn't see how it would work when so many other failed at it.

Me I discussed it with Bill and found him to be completely clueless, can the business work yes it can and does for a lot of loan companies but what Bill and Paul were doing was a mickey mouse operation based on exploiting pay day loaning. Add to that someone's mentioning loans to businesses for shoes?? That's just unthinkable especially without talking to the investors.

Currently there is at least P1m outstanding on the lending, most of the small investors got their money back as its easy to silence a lot of small voices as they will simply not care once they get their money. The big losers in the scheme seem to be talking to each other and pretty much I am not involved in it. I didn't invest in the scheme anyway and its upto them to sort out what they want to do but they are looking at legal action.

Back toAmericano, do I think there is more going of course I do and I would be surprised if Paul and Philip are not in some form of connection even now. Its all rather convenient thatAmericano is linked to Bills wife at the same time when the assault happened someone mentioned where was Philip? Which several have dismissed as asleep, but like your image shows with the two girls at the same time my thoughts were bed hopping. Had Philip and Paul swapped girls that evening and that's what really happened? I don't know but I have been here long enough to see some very extreme lies come about when people are allowed to make up their own stories. The Ian Griffiths and Bella Santos case for example the PNP are lying, the prosecution are manipulating the court, fake witnesses were introduced and slowly collapsing as each one is put to the stand. Drug addicts, liars and people looking to make money from the reward. I remember the story when it originally happened and I also remember talking to the PNP about it when they asked me to hack Bella Santos's emails to locate her and find out any information on the murder. I asked one simple thing "do you have any evidence?" response was "none". This is the arresting officers, this is before the altered number plates on the vehicle.

But the statement was made as if the case was already raised but by who? I am not aware of anything that has actually been processed to make this happen and I am sure if I made a call to Abellion the main immigration prosecutor at Mandaue he would say the same.

I have however messaged the journalist that was in the photo when Paul was arrested to ask if he wanted to pick up the case to why Paul is back after being deported, but still awaiting a response.

If I had more time I would delve into Pauls life more deeply as its his past that's more important than current as he's got skeletons here in Cebu. His links with Alister the owner of Lonestar is a major one as Alister has been here around 18 years and owns at least 30 restaurants. Why own a brothel when he's making serious money with his restaurants, furniture exports, jewellery exports and other ventures? This is why I wondered about links with Bennetts and his sites is this how Paul and Bennetts link together with girls being supplied by the bar for porn?

The LiC is new and give it time voices will surface that were shot down elsewhere. I watched the Legacy scandal happen and then seen Paul as well as David Whittle shut everything down from LinC to Yahoo groups banning everyone who went against them. David even to this day threatens to sue people for slander.. Yet had no problem with people losing money on V4 after Legacy and what happened to his 5% a month on the rice venture? Well last time I seen David I intercepted a msg between him and I believe his wife's daughter in HK that was requesting money. He owed the banks P250,000 and was working as an English teacher for Koreans in Lahug temporary. The pot is empty, it appears they are all running dry of cash and its maintaining pressure and open topics that will keep them from gaining access to other peoples money.
